No holder of the shares of the Company was required to abstain from voting at the AGM under the under the Rules Governing the Listing of Securities of The Stock Exchange of Hong Kong Limited.

In addition, no party has indicated in the circular of the Company dated 11 April 2017 that he intends to vote against or to abstain from voting on any of the Resolutions at the AGM.

Messrs. Ernst & Young, the auditors of the Company, was appointed as scrutineer for the vote-taking in the AGM.
