As at the date of the AGM, the total number of shares of the Company was 2,175,200,000, which was the total number of shares entitling the holders to attend and vote for or against the Resolutions at the AGM. No holder of the shares of the Company was required to abstain from voting at the AGM under the Rules Governing the Listing of Securities of The Stock Exchange of Hong Kong Limited.

In addition, no party has indicated in the circular of the Company dated 12 April 2018 that he intends to vote against or to abstain from voting on any of the Resolutions at the AGM.

Wellink CPA Limited, an external certified public accountants who are qualified to serve as the auditors of the Company, was appointed as scrutineer for the vote-taking in the AGM.
